

## Report of the Marine Environmental Quality Committee

The business meetings of the Marine Environmental Quality Committee (MEQ) were held on October 19 (18:00-20:00) and October 22 (14:00-18:00), 2014, in Yeosu, Korea. The meeting was attended by 11 members, representing all PICES member countries, and 15 observers (*MEQ Endnote 1*). MEQ Chair, Dr. Chuanlin Huo, called the meetings to order and welcomed all participants. MEQ members and observers were asked to provide self-introductions and a brief statement about their interests and expertise. Thirteen agenda items were completed during the day 1 and day 2 meetings (*MEQ Endnote 2*).

### Implementation of PICES-2013 decisions

MEQ sponsored or co-sponsored the following topic sessions and workshops at PICES-2014 (see [Session Summaries](#) elsewhere in the 2014 PICES Annual Report).

- MEQ Paper Session: (Oct. 22, ½ day). Co-Convenors: Chuanlin Huo (China) and Darlene Smith (Canada). In view of dwindling themes and contributions for the MEQ-P session, MEQ participants provided suggestions for new topics and direction to make MEQ-P more appealing.
- MEQ Topic Session S8: “*Marine debris in the Ocean: Sources, transport, fate and effects of macro- and micro-plastics*” (Oct. 23, ½ day). Co-Convenors: Won Joon Shim (Korea), Peter S. Ross (Canada), Olga Lukyanova (Russia), Sangjin Lee (NOWPAP), Peter Kershaw (GESAMP) and Jesus Manuel Gago Piñeiro (ICES/Spain). Invited speakers: Marcus Eriksen (5 Gyres Institute, USA), Francois Galgani (IFREMER, France), Sunwook Hong, OSEAN, Korea) and Hideshige Takada (Tokyo University of Agriculture and Technology, Japan).
- MEQ Workshop W3: “*Mitigation of harmful algal blooms: Novel approaches to a decades long problem affecting the viability of natural and aquaculture fisheries*” (Oct. 22, one day). Co-Convenors: Ichiro Imai (Japan), Changkyu Lee (Korea), Charles Trick (Canada) and Mark Wells (USA). Invited Speaker: David Kidwell (NOAA, USA).
- BIO/MEQ Topic Session S3: “*Tipping points: defining reference points for ecological indicators of multiple stressors in coastal and marine ecosystem*” (Oct. 21, 1 day). Co-Convenors: Rebecca G. Martone (USA), Ian Perry (Canada), Jameal Samhoury (USA), Motomitsu Takahashi (Japan), Maciej Tomczak (ICES/Poland) and Chang-Ik Zhang (Korea). Invited Speakers: Phil Levin (NOAA, USA) and Tetsuo Yanagi (Kyushu University, Japan).

### Review of main achievements in 2014

Dr. Huo reviewed the main achievements of the Committee over the past year, including:

- the establishment of Working Group (WG 31) on *Emerging Topics in Marine Pollution*;
- Working Group (WG 28) on *Development of Ecosystem Indicators to Characterize Ecosystem Responses to Multiple Stressors* evaluated the impacts of human activities and natural stressors using a habitat-stressors matrix;
- the Section on *Ecology on Harmful Algal Blooms (S-HAB)* developed a new set of terms of reference;
- two topic sessions, one paper session, and one workshop were convened at PICES-2014,
- publication of two PICES Scientific Reports (PICES Sci. Rep. No. 46, Report of the Study Group on Marine Pollutants, P.S. Ross (Ed.) and PICES Sci. Rep. No. 47, Proceedings of the Workshop on Economic Impacts of Harmful Algal Blooms on Fisheries and Aquaculture, V.L. Trainer and T. Yoshida (Eds.)).

### AGENDA ITEM 4

#### **Relations with other groups/organizations**

Dr. Huo discussed MEQ progress on cooperation with other groups and organizations, such as NOWPAP. Dr. Takafumi Yoshida (NOWPAP) talked about the work his organization was involved in, and on collaboration with PICES on marine environmental issues, especially on the priorities of the two organizations, such as harmful algal blooms and marine pollution.

The midpoint review of FUTURE highlighted the need for change in governance and the creation of a Science Steering Committee (SSC) recommended by Science Board. Dr. Won Joon Shim (MEQ) will be one of the Korean members of the SSC. Dr. Huo asked MEQ members to suggest other candidates for the new SSC.

### AGENDA ITEM 6

#### **Reports from MEQ expert groups**

All expert groups under MEQ were represented at the MEQ Committee meeting, and the Chair/Co-Chair from each group reported their work and progress in 2014 (see *MEQ Endnote 3* for proposals and funding requests). MEQ member (and Chair of the Study Group on *Biodiversity Conservation* (SG-BC)), Dr. Janelle Curtis, presented her report on SG activities and recommended the establishment of a Working Group on *Biodiversity and Biogenic Habitats* to investigate coral and sponge ecosystems.

Working Group (WG 28) on *Development of Ecosystem Indicators to Characterize Ecosystem Responses to Multiple Stressors*

- The group is making good progress on its TORs;
- A paper on “*Developing ecosystem indicators for responses to multiple stressors*” (lead author: Jennifer L. Boldt) has been accepted in *Oceanography* and will be published in late 2014 or early 2015;
- A review of several frameworks to address cumulative impacts of human activities and natural stressors on marine ecosystems in the North Pacific is being done;
- Multiple stressors are common, and the WG is considering the impacts of 20–50 stressors on 20 ecosystem types;
- A final report outline has been produced. A number of recommendations for further work are anticipated:
  - i. Dr. Perry noted that WG 28 will provide a list of topics for Working Group on *Emerging Topics in Marine Pollution* (WG 31) to address, and there will be recommendations for other expert groups as well (*e.g.*, S-HAB),
  - ii. A draft final report will be produced in 2015 as expected,
  - iii. Final report will be submitted at ISB-2016.

Working Group on *Assessment of Marine Environmental Quality of Radiation around the North Pacific* (WG 30)

- A 2-day meeting was held on October 17–18, 2014 with 8 of the 13 members in attendance.
- Good progress is being made on terms of reference, and the WG is conducting field monitoring and circulation modeling;
- WG 30’s work plan for 2015 is to:
  - i. Submit a paper to a journal (TBD).
  - ii. Conduct a workshop at PICES-2015 to discuss data gaps with invitations to SCOR, IAEA + ICRP.
  - iii. WG 30 member, Dr. John Smith, is also a member of the SCOR Working Group on Radioactivity in the Ocean, and PICES has been invited to participate. This could cost \$10k for travel.

### Section on *Ecology of Harmful Algal Blooms in the North Pacific* (S-HAB)

- S-HAB is contributing to the North Pacific Ecosystem Status Report by providing information on mechanisms underlying HAB occurrence and environmental changes.
- Proceedings of the Workshop on Economic Impacts of Harmful Algal Blooms on Fisheries and Aquaculture (V.L. Trainer and T. Yoshida (Eds.)) was published in 2014 in PICES Scientific Report No. 47.
- An article on S-HAB contribution to FUTURE and on the “Mitigation of HABs – the way forward” in PICES Press (2015).

### AGENDA ITEM 7

#### **Introduction of a new working group (WG 31)**

Dr. Won Joon Shim, Co-Chair of Working Group on *Emerging Topics in Marine Pollution* (WG 31) provided a brief background and terms of reference of the WG, which was established after PICES-2013. Ten out of 17 WG members and several observers were able to attend its first business meeting. Main achievements thus far are:

- A 1-day MEQ Topic Session (S8) in 2014 meeting, entitled “*Marine debris in the ocean: Sources, transport, fate and effects of macro- and micro-plastics*” was held at PICES-2014. There were 17 oral presentations and 10 posters. Marine debris in the Ocean: Sources, transport, fate and effects of macro- and micro-plastics: Total 17 oral and 10 poster presentations on 23 October 2014;
- A Report of the Study Group on Marine Pollutants P.S. Ross (Ed.) was published as PICES Scientific Report No. 46 in 2014;
- The WG will commit to promoting the MEQ paper session at PICES-2015 to ensure better success.
- WG 31 proposes a 1-day Topic Session on “*Indicators of emerging pollution issues in the North Pacific Ocean*” and 1-day workshop on “*Marine environment emergencies: Detection, monitoring and response*” workshop at PICES-2015.
- next steps:
  - i. Discussed data compilation of marine pollution indicators,
  - ii. Proposing topic sessions for PICES 2015 and PICES 2016,
  - iii. Biomarkers possible subject for the topic session,
  - iv. Publication special issue on micro-plastics.
