2022 Governing Council Decisions

The following Governing Council Decisions were taken at the PICES-2022 Governing Council Meeting, held October 1-2 2022, in Busan, Republic of Korea

2022/A/1. Auditor's Report and letter.

- i. Council accepted the audited accounts for FY 2021.
- ii. Council accepted the recommendation from the Finance and Administration Committee that the following changes be made to the Financial Regulations (new text is <u>underlined</u>):
 - a) Regulation 10(iv)a be modified to read "For all purchases and contracts for equipment and office supplies exceeding an amount set by the Council, <u>currently \$10,000</u>, the Executive Secretary shall solicit written proposals....etc. <u>This amount to be reviewed by Council as desired but no longer than every 5 years.</u>"
 - b) Financial Regulation 12 (v) to be modified so that the final sentence now reads "<u>The</u> amount which accrues from such assessments shall be credited to the Relocation and Home Leave Fund to defray expenses of the Organization".
 - c) Financial Regulation 6 (vii) to be modified so that the third sentence now reads "The Relocation and Home Leave Fund is to be financed first from the levy in lieu of taxes from Secretariat staff, and if the year-end balance is below \$0 then from the General Fund surplus at year-end, then tax refunds, then the WCF reserve and then annual appropriations if necessary"
 - d) The following new Financial Regulation to be added:

 Regulation 6(x) Accrued severance and unused vacation (beyond the current year) shall be listed as a liability against the Home Leave and Relocation Fund in the annual accounts of the Organization and a balance maintained in this Fund at or above \$0 at year end. When an individual's employment ends the amount owing for severance (for employees that began their term prior to 2017) and unused vacation beyond the current year will be paid from the HLRF. Unused vacation days for the current year will be paid from the General Fund.
 - e) Staff Rule 16 be amended to refer to Financial Regulation 12 (i) and not Regulation 11 (i)

2022/A/2: Annual Contributions.

- i. Council re-iterated the importance for all Contracting Parties to pay the Annual Fee by the January 1 deadline and confirmed that, for planning of their funding requests for annual contributions, Contracting Parties should continue to use the guideline generally accepted at PICES-1999 (Decision 1999/A/2(ii)), which states that the annual contributions will increase at the rate of inflation in Canada.
- ii. Council instructs the Executive Secretary to send letters to all Contracting Parties requesting payments of Annual Fees as soon as practical following the Annual Meeting.

2022/A/3: Budgetary Considerations

- i. Council approved the FY 2023 budget of \$1,156,000 and set the 2023 annual contribution at \$148,700 per Contracting Party for a total of \$892,200.
- ii. To address the pension plan liability, Council recommends that each Contracting Party make an additional \$8000 Extraordinary Contribution for FY2023 and that the Extraordinary Contribution shall continue until pension plan liability is extinguished.

- iii. Council approved a transfer of \$215,800 from the Working Capital Fund to the General Fund on January 1, 2023 to balance the budget.
- iv. Council approved a transfer from the Working Capital Fund to the Trust Fund on December 31, 2022 to recover the 2022 expenses and restore the Trust Fund to the level of \$110,000.
- v. Council approved the creation of an encumbered fund in the Working Capital Fund account as and when funds to support the BECI project are submitted to PICES.
- vi. Council approved renaming the "ICES-PICES Joint Sci Conf IP23" Fund within the Working Capital Fund as the "PICES-2023 USA" Fund

2022/A/3: Voluntary Contributions for the Intern Program and Capacity Building

- i. Council instructs the Executive Secretary to invite Contracting Parties to provide voluntary contributions to the Trust Fund to support the Intern Program and capacity building activities in 2023 and beyond.
- ii. Council encouraged all Contracting Parties to consider nominating an intern and to do so as soon as possible so that a new intern can be in place for spring 2023.

2022/A/4: Financial Reserve

- i. Council approved a Reserve Fund within the Working Capital Fund which should be maintained at or above a level equal to twice a contracting party's annual fee.
- ii. The Reserve Fund is to be reviewed annually by the F&A Committee to ensure that the Reserve available at the prior fiscal year end is within an acceptable margin of the level set in i) above, and if it is not then the F&A Committee to recommend an appropriate mechanism for restoring the Reserve.

2022/A/5: Future PICES Meetings

- i. Council accepted the offer of the USA to host PICES-2023 in Seattle, with dates of October 20-29, and approved the expenditure of up to \$40,000 from the General Fund to defray the costs of the 2023 Meeting.
- ii. Council agreed the following fee structure for PICES-2023:

- iii. Council approved a virtual Intersessional Science Board meeting in spring 2023.
- iv. Council noted the agreement from Russia to host PICES-2024 at a time and location to be determined.
- v. Council invites Japan to explore the possibility of hosting the 2025 Annual Meeting, and inform the Secretariat on this matter by March 31, 2023.

2022/A/6: Science Products

Council directs the Executive Secretary to provide a follow-up report to the Finance and Administration Committee at PICES-2023 which determines whether the needs for science products are being sufficiently met and taking into account:

- The products of the AP-SciCom workshop and business meeting at PICES-2022
- The activities and outputs of the AP-ECOP
- The outcome of the UNDOS intern proposal at PICES-2022
- The range of science product preferences within PICES member countries determined by followup discussions with GC members.

2022/A/7: UN Observer Status

Council directs the Chair and Executive Secretary to move forward with the process for acquiring UN Observer status for PICES.

2022/A/8: External Review of the Organization

Council directs the Chair and executive Secretary to provide draft Terms of Reference for the Study Group (SG-ER) to review. The Study Group to then provide the Terms of Reference to Council for approval intersessionally.

2022/A/9: Appointment of Chair/Vice Chair of PICES and Chair of the Finance and Administration Committee.

- ii. Dr Tetsuo Fujii was elected to a second term as Vice Chair of PICES
